If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. In-Network <u>preventive care</u> , office visits, certain diagnostic tests, certain imaging, certain <u>prescription</u> <u>drugs</u> , outpatient surgery, <u>urgent care</u> , <u>emergency</u> <u>room</u> , outpatient <u>rehabilitation</u> are covered before you meet your <u>deductible</u> .
