| Are there services covered before you meet your deductible? | Yes. In-Network preventive care , office visits, certain prescription drugs , urgent care , emergency room , outpatient rehabilitation are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . | What is not included in the out-of-pocket limit? | Premiums , prescription drug brand additional charges and manufacturer assistance, balance billing charges, and health care this plan doesn't cover. | Even though you pay these expenses, they don't count toward the out-of-pocket limit . |
| Will you pay less if you use a network provider? | Yes. See www.avmed.org or call 1-800-882-8633 for a list of network providers . | This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). This is not a cost estimator. Treatments shown are just examples of how this [plan](#) might cover medical care.
