Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">In-Network preventive care</a> , office visits, certain <a href="#">prescription drugs</a> , <a href="#">urgent care</a> , outpatient <a href="#">rehabilitation</a> are covered before you meet your <a href="#">deductible</a> .
